

# Website Acceptable Use Policy

This website acceptable use policy sets out the terms between you and us under which you may access our website Fuzzyinsurance.com (our site).

This acceptable use policy applies to all users of, and visitors to, our site.

# Prohibited uses:

- Advocate, promote or assist any unlawful act such as (by way of example only) copyright infringement or computer misuse.

### Suspension and termination

We will determine, in our discretion, whether there has been a breach of this acceptable use policy through your use of our site.



# Breach of this Policy

When a breach of this policy has occurred, we may take such action as we deem appropriate. Failure to comply with this acceptable use policy constitutes a material breach of the terms of use upon which you are permitted to use our site, and may result in our taking all or any of the following actions:

- Immediate, temporary, or permanent withdrawal of your right to use our site.
- Immediate, temporary, or permanent removal of any posting or material uploaded by you to our site.
- Issue of a warning to you.
- Legal proceedings against you for reimbursement of all costs on an indemnity basis (including, but not limited to, reasonable administrative and legal costs) resulting from the breach.
- 4 Disclosure of such information to law enforcement authorities as we reasonably feel is necessary.
